# **Event Code of Conduct**

#### Summary

Infrastructure Masons, Inc. ### **Participant Pledge**

By checking this box and clicking "I Accept", I pledge to:

- Comply at all times with this Event Code of Conduct, any event specific rules and applicable laws.
- Treat all iMasons Members, representatives, guests, sponsors, exhibitors and staff with respect and maintain a professional demeanor.
- Act with honesty, fairness, courtesy, competence, integrity, and professionalism.
- Attend and participate solely in events and breakout sessions for which I have received an invitation and completed the required registration.
